A simple but powerful user interface allows for extensive search and audit capabilities.

It offers the hard disk drive capacity ranges, tape format choices, and price points that perfectly fit the needs of small and midsize businesses - whether you're looking for an email archiving solution for regulatory compliance, legal discovery (e-discovery), or simply good business practices.

Email messages are not just conversations—they're business records, which must be managed accordingly. As a result, email archiving is being rapidly adopted today in organizations of all sizes for:

- Legal discovery (e-discovery)

Most small to mid-sized firms have not yet been able to comply with regulations for email retention, whether in SEC-regulated environments or otherwise. The reason is two-fold: complexity and high cost. Previous solutions for email archiving, designed for large enterprises, are difficult for small firms to implement because they require specialized IT expertise, and go well beyond modest IT budgets.

The device allows companies to meet a variety of email retention needs whether related to regulatory compliance (SEC 17a-4, NASD 3110, FDA 21 CFR Part 11, HIPAA, etc.), or simply for good business practice in electronic records management. The ComplianceVault Appliance also allows for rapid searching of email to improve responsiveness to litigation discovery requests.

Archive, search, retrieve, audit, and encrypt

- **Easy to install, easy to operate**—sets up in minutes, and doesn't affect a company's existing IT infrastructure.
- **Complete Solution**—includes 1U server platform, hard disk drives, tape autoloader, application software, graphical user interface, Ethernet 10/100/1000 networking, 110/220 volt AC power, rackmount rail kits, cables, and technical support. No additional per-user costs, license costs, software maintenance costs, or other ongoing costs (other than removable media for the tape autoloader).
- **Unique Capability**—comes with customer's choice of Exabyte VXA-2, VXA-320, Ultrium™ LTO-2, or Ultrium™ LTO-3 tape autoloaders - based on award-winning and widely adopted technologies. WORM capability is available with the Ultrium™ LTO-3 solution option, for regulatory compliance requiring write-once, read-many (non-alterable) media.

- **Robust search capabilities**—including wildcard searches, fuzzy searches, proximity searches, and range searches to boost relevance levels, also with the ability to save searches.
- **Efficient**—email attachment management ensures no duplicates, since the system retains only one original.
- **Exporting of search results**—the ability to easily export any email search results directly from the search results screen to a file, to a CD, to an email, or to a printed hardcopy. This feature greatly facilitates use of the system for response to regulatory auditors, for legal discovery, or for review by a company's legal counsel.
- **Extensive audit features**—for better audit reporting and control. Every single access to the system is tracked by date, time, and user, providing a full audit log.
- **Encryption**—the appliance provides the option of tape encryption, to safeguard tapes from data theft or loss. EncryptTape™ technology is based on the same type of encryption used by the U.S. Federal Government, the highest level available, which is AES 256-bit—called "strong encryption".
